在車輛登記文件簽署及蓋印規定

車輛登記文件(以下簡稱為「牌簿」)上<u>必須</u>載有登記車主簽署,而當登記車主遞交有關的牌照申請時,申請表格上的簽署必須與牌簿上的簽署相符;如以公司/機構為登記車主,牌簿必須載有由該公司/機構所指定獲授權人士的簽署並加蓋該公司/機構的印章,而申請表格上的印章與牌簿上的印章<u>必須完全相同</u>,否則運輸署將<u>不會</u>處理有關的牌照申請。

地址證明要求

於遞交牌照服務申請時,必須連同最近三個月內發出的地址證明文件正本或副本,否則運輸署可以根據有關法例暫停處理有關申請。「請參閱可接納的地址證明

更改地址

根據法例,駕駛執照持有人或登記車主的地址如有改變,須在 72 小時內通知運輸署。任何人無合理辯解而違反此規定,即屬犯罪,可處罰\$2,000。你可透過書面、政府一站通或遞交表格(「更改個人資料或車輛資料通知書」) 連同新地址的證明文件通知運輸署有關地址的更改。

注意事項 NOTES FOR ATTENTION

- (1) 如任何駕駛執照持有人/登記車主曾向運輸署署長提供其**姓名、地址或身分證明文件**有所改變,他/她須在改變出現後 72 小時內以書面 通知運輸署署長,並需提交有關改變的證明。任何人無合理辯解而違反此規定,即屬犯罪,可處罰款 2,000 元。如屬姓名的改變或身分證 明文件的改變,駕駛執照持有人/登記車主亦須將現有的駕駛執照正本(如持有)、駕駛教師執照正本(如持有)、車輛登記文件正本(如持有)、車輛牌照(如持有)及自訂登記號碼分配證明書(如持有)送交運輸署署長,以作修改;
- (2) 運輸署署長在處理牌照申請時,可要求申請人出示其**現時地址的證明**(住址/公司地址及通訊地址,例如水/電/煤氣/手提電話費單或銀行信件等,而該地址證明需距今不超過三個月),以及可在申請人出示該等證明之前,<u>暫停處理該申請</u>。因此,請申請人帶同現時地址的證明,並在牌照事務處人員要求下,出示該地址證明;
- (3) 所有在本署以你的身分證明文件/公司註冊證號碼登記的車輛牌照或駕駛執照的記錄,會根據你在本通知書內填報的地址而同時更改。
- (4) 在完成辦理你的申請後,你所提交的證明文件副本將會被銷毀。
- (1) If a change occurs in the **name**, address or identity document of a driving licence holder/registered vehicle owner previously provided by the driving licence holder/registered vehicle owner to the Commissioner for Transport, the driving licence holder/registered vehicle owner shall, within 72 hours of the change, notify the Commissioner for Transport in writing with the proof of change. Any person who without reasonable excuse contravenes such requirement commits an offence and is liable to a fine of \$2,000. For cases of change of name or change of identity document, the driving licence holder/registered vehicle owner shall also deliver to the Commissioner for Transport the existing original driving licence (if applicable), original driving instructor's licence (if applicable), original vehicle registration document (if applicable), vehicle licence (if applicable) and Certification of Allocation of Personalized Registration Mark (if applicable) for amendment.
- (2) The Commissioner for Transport may, in processing licensing application, require the applicant to **produce proof of his/her present address** (residential/company and correspondence address, e.g. water/electricity/gas/mobile phone bill or bank correspondence), and may <u>suspend the processing of the application</u> until the production of such proof. Applicants please bring along your proof of present address which is issued not more than 3 months from now for presentation as and when requested by officers of licensing offices.
- (3) For any change of address notified in this notice, all vehicle/driving licence records of the applicant under the same identity document/ Certificate of Incorporation held by this Department will also be changed.
- (4) Copy of your submitted supporting document(s) will be destroyed after processing your application.

退回有效車輛牌照費 REFUND OF UNUSED VEHICLE LICENCE FEE

如你的車輛牌照於通知取消登記時距屆滿日期 60 日或以上者,按照香港法例第 374 章《道路交通(車輛登記及領牌)規例》第六附表,你可領回部份牌費。運輸署各牌照事務處均備有關的附表,以供查閱。本署於收到取消車輛登記的通知後,會作出安排,由庫務署通知你領回該款。

If on the date of notification, the unused part of your vehicle licence is 60 days or more, you are entitled to a refund of a portion of the licence fee in accordance with the Sixth Schedule to the Road Traffic (Registration and Licensing of Vehicles) Regulations (Cap. 374). Copies of the Schedule are available for inspection upon request at each Transport Department's licensing office. Arrangement for the refund would be made on receipt of your notification of cancellation of the vehicle registration and you would be informed by the Treasury for that refund.

When your vehicle is broken up, destroyed, or sent permanently out of Hong Kong, you are required by law to notify within 15 days the Commissioner for Transport in writing of such breaking up, destruction or despatch. If the vehicle is assigned with a personalized registration mark, the Certificate of Allocation concerned should also be returned at the same time, unless the personalized registration mark assigned to the vehicle is transferred or held in abeyance before the Commissioner cancels the registration of the vehicle.

 - (b) maintenance of a register of vehicles for public access under regulation 4(2) of the Road Traffic (Registration and Licensing of Vehicles) Regulations;

 $(applicable\ to\ vehicle-related\ applications\ only)$

- (c) maintenance of a record of particulars of driving licences under regulation 39 of the Road Traffic (Driving Licences) Regulations; (applicable to driving licence-related applications only)
- (d) activities relating to traffic and transport matters; and
- (e) facilitating communication between Transport Department and yourself.
- 2. It is obligatory for you to supply the personal data as required by this notice. If you fail to supply the required data, your application may be refused.

Classes of Transferees

- 3. The personal data you provided by means of this notice may be disclosed to:
 - (a) other Government departments, bureaux and relevant organizations for the purposes mentioned in paragraph 1 above;
 - (b) any person for the purpose mentioned in paragraph 1(b) above; and
 - (c) tunnel companies, Tsing Ma Control Area operator and Tsing sha Control Area operator for execution of their statutory duties in traffic and transport matters.

Access to Personal Data

4. You have a right of access and correction with respect to personal data as provided for in sections 18 and 22 and principle 6 of Schedule 1 of the Personal Data (Privacy) Ordinance. Your right of access includes the right to obtain a copy of your personal data provided by this notice.
